Karimun Regency to jointly discipline and obey health protocols to reduce and suppress the spread of the COVID-19 virus.

In addition, the Karimun Regency government also carries out strict supervision at national and international domestic ports, this is done so that the people of Karimun Regency are not contaminated with viruses from neighboring countries. The Karimun Regency Government has disabled sea transportation which is the main traffic access, especially in the economic cycle of the Karimun Regency community. Meanwhile, inter-island transportation also applies health protocols such as checking body temperature and equipped with health certificates to reduce the number of virus spreads in Karimun Regency.
